Monthly Fire Chief Update – December 2022 Subject:

Engineer's Test

The South San Joaquin County Fire Authority held an internal promotional exam for the position of Fire Engineer during the month of December. Six candidates were assessed by written exam and then by performing practical exam scenarios including; pumping multiple lines, aerial operations, drafting and pre-trip inspection. We are happy to announce all six candidates successfully passed and are in either the A or B band. This allows each candidate to work in an "out of class" capacity and will allow us to fill one vacant engineer position. Evaluators from neighboring departments complimented our candidates on their preparation and performance after the exams were completed. We hope to announce who will be promoted by February.

Badge Pinning Ceremony

The Fire Authority's Badge Pinning Ceremony was held at the Grand Theatre on December 20th. The ceremony recognizes members that were hired or received promotions over the past year. A total of 16 members were pinned, to include five Chief Officers, five Captains, four Engineers, a Plans Check Examiner and an Inspector. An additional fourteen Firefighters, one Permit Technician, and two Administrative staff members were recognized during the ceremony.





Firefighter of the Year



Kevin Meineke was selected as the Firefighter of the Year by his fellow members of the IAFF Union. He has stepped up in the absence of our full time EMS Coordinator to keep our ALS program alive and thriving. Kevin represents our department well at the County EMS level and has taken a prominent role in the EHR and ESO integration. He is a well-respected team player, a motivator, strong leader, and always does the right thing for the department and its personnel – both line and administrative staff.

Training

During December, the South County Fire Authority Division of Training continued to facilitate all risk emergency training events.

- All three shifts trained on Firefighter Survival and Rapid Intervention Crew tactics at our Support Facility Building
- All three shifts participated in Hazardous Materials First Responder Operations and decontamination (ISO Standard)
- Company Level training Our eight Probationary Firefighters worked on multiple skills including EMS and Fire related training that is required to be a successful firefighter
- Company Level training Over the past several months, our firefighters worked hard to prepare for the upcoming Engineer test
- Our Hazardous Materials Specialist attended a training scenario hosted by OES. Our HazMat team personnel worked with many Bay Area Departments to mitigate multiple HazMat scenarios.

At the company level our firefighters are training daily to better prepare themselves to assist in mitigating emergencies in our community. Personnel logged over 1300 hours of training in the month of December.

The Division of Training always supports the mission of the Fire Authority and its duty to provide a well-trained and professional fire agency to serve our community.

Community Events

- **December 3, 2022** Engine 91 participated in the City of Tracy's Parade of Lights and had the honor of having Mr. and Mrs. Claus on board! Three of our Explorers set up outside of the Administration Building and passed out candy canes and other goodies during the parade. Although it was a rainy evening, there was a large turnout.
- December 3, 2022 The Union hosted the annual Christmas Party where our six retirees
 were honored. They also selected and presented Captain Meineke with the Firefighter of
 the Year award.

Community Events (continued)

- **December 10, 2022** The Union hosted the annual Kid's Christmas Party. This event is for the families of our Fire Department members and personnel, and the kids get a chance to do arts and crafts, decorate cookies, and get a special visit (and presents) from Santa!
- **December 19, 2022** Engine 1 attended the Menorah Lighting Ceremony for the Chabad of Tracy Jewish Center at the Tracy City Hall and threw candy for the gelt drop.
- Brighter Christmas Each year a family is adopted by each Fire Station and the Administration Building. We also participated in the Brighter Christmas "Jail & Bail" fundraiser, where the Chief is placed in a virtual jail and gets bailed out by donations. Chief Bradley had a goal of \$600, and Authority Personnel raised a total of \$870.00.









Significant Incidents

- **December 4, 2022** Crews responded to a service call for a vehicle that crashed into a house off of Crossroads Drive just after 3:30 am. The vehicle crashed into a downstairs bedroom, and luckily both the resident and driver only suffered minor injuries.
- **December 5, 2022** Crews responded to a structure fire on the 500 block of West Grant Line Road. The structure was an abandoned house and was fully involved when they arrived on scene. The property is a well known gathering area for the unsheltered and had caught fire at least four times prior. No injuries were reported.

Significant Incidents (continued)


 December 21, 2022 – Crews provided mutual aid to Alameda County Fire Department during a structure fire in the unincorporated area of Livermore. Engine 95 and Water Tender 90 assisted approximately 30 other firefighters from multiple agencies and were on scene for over two hours. No injuries were reported, however two people were displaced.






December 2022 Response Data

There were 1,000 total reported incidents in the month of December 2022. EMS incidents continue to be the predominant incident type (659 incidents comprising 66% of all calls for service). While where were 1,000 calls for service, it is important to note that some calls require multiple apparatus. In total there were 1,560 total apparatus responses in November.



Station 91 continues to be the busiest fire station in the month of December. There are two staffed units responding from Station 91; Truck 91 and Engine 91. Six of our seven stations experienced call increases in December.



The Joint Powers Agreement of the South San Joaquin County Fire Authority states the Chief Executive Officer will provide the Board of Directors a report on the staffing levels at each station. Authority fire engines and the ladder truck are staffed with 3 persons each. There is one Battalion Chief on duty each day to supervise one of three shifts.





Fire Inspection Totals:




YTD STATE-MANDATE INITIAL FIRE INSPECTIONS



Annual Revenue




MONTHLY COMPLETED INSPECTION COMPARISON




YTD FIRE INSPECTION OVERVIEW

Completed Fire Inspections Per Zone:




Completed Fire Inspections Per Type:

• 19 new construction permits were issued in December


ADMINISTRATIVE ACTIVITIES
