Chief Martin Retires



On November 19, 2023, Chief Martin retired from the South San Joaquin County Fire Authority after 30 years of service. Chief Martin began his career as an Engineer with Tracy Fire in 1993 and worked his way up through the ranks over his 30-year career. He was promoted to Captain in 1997, Battalion Chief in 2017 and Division Chief of Administration in August of 2022. He holds an AS Degree in Fire Science and has been active member of the labor union holding all positions on the executive board. Firefighter Recruitment

We are pleased to announce that we have a total of four candidates who are currently going through background processes. Successful candidates will start in January and will attend the Firefighter Academy hosted by the Stockton Fire Department beginning February 1st.

Travel & Conferences

• Chief Bagley attended the New Executive Chief Officer course at the National Fire

Academy in Emmitsburg, Maryland from October 28th – November 4th. This course is paid for by FEMA and focuses on curriculum for Chief Executive Officers. Curriculum covered responsibilities of the Fire Chief, politics, leadership management, strategic planning, financial management and capital asset planning, Human Resources management, liability and risk management, collaboration-cooperation and community engagement.



 Chief Bradley attended the Cal Chiefs EMS Section North meeting in South Lake Tahoe on November 16th. This meeting occurs bi-monthly and Chiefs from all over California meet to discuss current EMS issues.

Chief Bagley presents at the California Special Districts Association chapter meeting

The California Special Districts Association (CSDA) Bi-County Chapter meeting with San Joaquin County and Stanislaus County is held on a quarterly basis. SSJCFA is a member of CSDA and the Chapter asked if we could present at November's meeting. Chief Bagley attended the meeting at the Modesto Irrigation District Office and presented the South San Joaquin County Fire Authority's JPA Model. We look forward to being more involved with CSDA in the future.





EMS Study

SSJCFA, Lodi and Stockton Fire Departments entered into an agreement with AP Triton to conduct an Emergency Medical Services (EMS) System Evaluation and Delivery Modeling. Chief Bradley and EMS staff met with the senior consultant at Healthcare Strategists and will be developing the RFP for the next ambulance contract. The project is estimated to take approximately six months to complete and we hope to have the final report by mid-year 2024.

Leprino Foods


In March of 2021, Leprino Foods had a HAZMAT incident at their Tracy site involving a leak of anhydrous ammonia which resulted in a fine from the Environmental Protection Agency (EPA). As a result of this incident, Leprino Foods was offered the opportunity to engage with the Authority on a Supplement Environmental Project Agreement (SEP). The SEP Agreement is an enforcement settlement that allows the penalized agency to redirect up to 50% of the fine to another agency that would provide a tangible environmental or public health benefit. This presents a potential funding opportunity up to \$180,000, which will allow SSJCFA to procure multiple pieces of simulation training equipment and a HAZMAT sensing drone.

SSJCFA continues to await final decisions and funding status from the EPA. The latest update was received on November 29th and Leprino Foods advised that the EPA has reviewed and accepted their response and offer. Leprino Foods affirmed that the agreement is under review by EPA's management, but do not have an update on the timeframe that we can expect a sign off and further direction on the next steps.

Training Facility Update

Training Facility construction drawings are now 100% complete and are now in the review process. This will go to Council for consideration of land commitment on January 15th and if approved we plan to go out to bid on January 16th. The provided photos include a rendering for the proposed classroom buildout and a copy of the site detail plan.





Training

During November, the South County Fire Authority Division of Training continued to facilitate all risk emergency training events.

- Driver Operator Training
- Paramedic Infrequent Skills
- Structure Fire Simulations
- Boat Operations Awareness Training

Authority personnel logged over 1,300 hours of training during the month of November. The Division of Training is dedicated to supporting the mission of the Fire Authority to provide a well-trained and professional fire agency to serve our community.

Captain Havicus Memorial Plaque Ceremony

South San Joaquin County Fire Authority held a Memorial Plaque Unveiling Ceremony to honor Captain Daniel "Havi" Havicus on November 8th. The ceremony was held at the Fire Administration Building's courtyard to unveil the engraved plaque that was installed on the memorial monument. In the months preceding, Hometown Heritage held a brick fundraiser to fund the plaques being made and installed. The bricks will be installed in the courtyard surrounding the statue and monument. These monuments are open to the public and will stand to honor our fallen and their sacrifice for years to come.



Get together for Heather Freligh

On November 1, 2023, SSJCFA held a small ceremony for Heather Freligh and her family at the Administration Building. Heather is a 13-year-old Tracy resident who had gone into full arrest at Freiler Elementary school on September 22, 2023. Staff worked with Heather's father to arrange this gathering so she and her family could meet some of her rescuers. Four of the six Authority personnel who responded to her call were able to attend. We were all able to spend time together and we are so thrilled at her outcome and recovery.



Board Action Recap

The Board of Directors for the South San Joaquin County Fire Authority met in a Regular Meeting on November 8, 2023. The Board took the following actions:

- Adopted a resolution to approve the updated Master Pay Schedule and publicly available pay schedule for the South San Joaquin County Fire Authority retroactive to July 2, 2023
- Approved the signing of a side letter with the Tracy Firefighter's Association (TFFA) to correct a date error and memorialize current practices in the current Memorandum of Understanding regarding future medical contributions
- Approve a new contract with additional funding between SSJCFA and Schack & Company for the continued development of site plans and construction documents for the fire training facility
- Adopted the final budget for the fiscal year 2023 2024
- Approved the Fire Chief to have authority to enter into a master services agreement for emergency management planning consulting provided by TetraTech Inc, not to exceed \$100,000
- Established an Ad Hoc Committee to develop recommendations for board review on the allocation of surplus funds from fiscal year ending June 30, 2023

Emergency Response Highlights


- November 11, 2023 At approximately 3:45 AM, crews were dispatched to a vehicle rollever accident requiring extrication on Highway 205 at Grant Line Road. Moments later the call was updated that a pedestrian who stopped to help was hit by a big rig. Unfortnately the victim succumbed to their injuries.
- November 12, 2023 Crews responded to a call for smoke being sceen from a residence on 21st Street. Upon arrival, crews found a bedroom fire and they were able to keep it to the room of origin. No injuries were reported, however nine people were displaced from the home.
- November 30, 2023 Just after 5:45 PM, crews were dispatched to a call for a vehicle
 accident involving a big rig and two vehicles on Eastbound Highway 205 at MacArthur
 Drive. Multiple injuries were reported and one fatality.





November 2023 Response Data


There were **835 reported incidents** in the month of November 2023, reflecting a slight decrease from the number of calls in October. EMS incidents continue to be the predominant incident type (557 incidents comprising 67% of all calls for service). While where were 835 calls for service, it is important to note that some calls require multiple apparatus. There were **1,364 total apparatus responses** in November.





November 2023 Response Data (continued)

Station 91 continues to be the busiest fire station in the month of November. There are two staffed units responding from Station 91; Truck 91 and Engine 91. Lastly, we are trending slightly below last year's call volume with **9,607** alarms in 2023 compared to **9,713** alarms in 2022.



The Joint Powers Agreement of the South San Joaquin County Fire Authority states the Chief Executive Officer will provide the Board of Directors a report on the staffing levels at each station. Authority fire engines and the ladder truck are staffed with 3 persons each. There is one Battalion Chief on duty each day to supervise one of three shifts.








FIRE INORESTICALS EVOLUS



FIRE INSPECTIONS FY 22/23




YTD STATE-MANDATE INITIAL FIRE INSPECTIONS



Annual Revenue




MONTHLY COMPLETED INSPECTION COMPARISON




YTD FIRE INSPECTION OVERVIEW

Completed Fire Inspections Per Zone:




Completed Fire Inspections Per Type:




PLAN REVIEW ACTIVITIES


- There were 72 plan check activities in November
